



Schedule of Rates – Chicago Metro District Wastewater/Sewer

In accordance with Illinois Commerce Commission regulations, the following rates for wastewater/sewer service have been in effect since April 23, 2010.

General Sanitary Sewage Service

Rates (per month)	Collection Service*	Collection and Treatment Service**
Residential units individually metered for water service	\$17.52	\$37.02
First 1,000 gallons	\$0.00000	\$0.0000
Over 1,000 gallons	\$0.01355	\$4.4968
Multiple residential units not individually metered for water service – per residential unit	\$14.02	\$29.62

Commercial and Industrial

The rate per 1,000 gallons, based on water usage, shall be as follows:

Rates (per month)	Collection Service*	Collection and Treatment Service**
First 20,000 gallons	\$1.2483	\$4.1688
Over 20,000 gallons	\$0.6340	\$3.3351

The minimum monthly service charge for commercial / industrial customers shall be \$6.58 for Collection Service and \$32.59 for Collection and Treatment Service.

* These charges are applicable to customers in those districts where only collection service is provided at company expense. These districts currently are: Alpine Heights, Chicago Suburban, Country Club, DuPage / Lisle, Fernway, Forest Estates, Moreland, Porter Golf, Rollins, Southwest Suburban (only areas east of Will-Cook Road and North 151st Street), Sunset Manor, Valley View, Waycinden, and West Suburban. To these charges will be added any amounts payable by the company to any public agency for sewage treatment and disposal as set forth in the Purchased Sewage Treatment Surcharge Rider.

** These charges are applicable to customers in those districts where waste treatment is provided at the company's investment or expense. These districts currently are: Arbury, Central States, Nettle Creek, Ridgecrest, River Grange, Santa Fe, Southwest Suburban (except areas east of Will-Cook Road and North 151st Street), Terra Cotta, and Valley Marina.

Valley View Service District Monthly Supply Charge

Residential units individually
metered for water service \$15.00

Multiple residential units not individually
metered for water service –
per residential unit \$12.75

Commercial – rate based on water usage \$2.56 per 1,000 gallons

Romeoville Wholesale Transportation and Treatment Services Agreement Monthly Supply Charge

Residential, commercial, and industrial –
rate based on water usage \$5.03 per 1,000 gallons

Rollins Service District Monthly Supply Charge

Residential units individually
metered for water service \$18.50

Multiple residential units not individually
metered for water service –
per residential unit \$15.73

Commercial – rate based on water usage \$4.31 per 1,000 gallons

State Tax Recovery Charge

A state recovery charge will be applied to all facilities charges, use charges, and public fire protection service charges at the rate of 0.1%.
